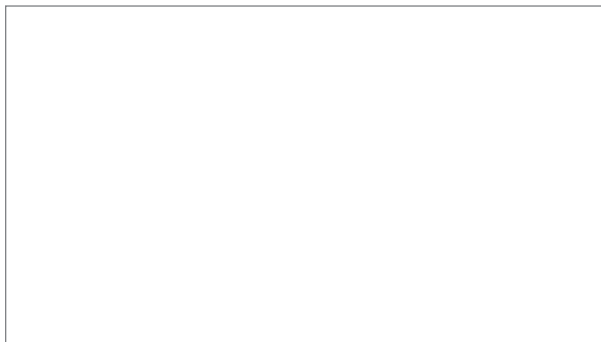

How can I become a Life Group Leader?

There are **three** ways to qualify as a Crown Financial Ministries life group leader:

1 If You ARE a Crown Life Group Member

You must attend a two-hour Life Group Leader Training session. Contact your local Crown director or church coordinator for training times and locations. You will need a Leader's Guide to attend this session.

2 If You Are NOT a Crown Life Group Member

You must attend a Life Group Leader Training session. Our goal is to help you understand the format of Crown studies and prepare you for the life group breakout sessions during the training. These Life Group Leader Training sessions are usually on Saturdays from 9AM–3PM.

These regularly scheduled sessions are held throughout the country, and training schedules are updated weekly. Contact your local Crown director.

3 If There Is No Training in Your Area

You'll need to purchase the leader training self-study packet from Crown. This packet includes all the materials and instruction necessary for you to become a qualified life group leader. An online testing process submits your name to Crown's database as a leader.

Additional Information

- To lead a Crown Financial Ministries Life Group Study you must have a certified co-leader.

As Christ sent out His disciples two by two, we require a model of accountability and partnership. Every life group must have two trained leaders from separate families, which allows for the continuity of the weekly sessions in the event that a leader is absent.

- Any potential leader should be approved by the church leadership if the study is conducted within a church.
- Active support of the church leadership is essential to life group leaders.

Leader Training Requirements

We recognize that the leading of a Crown life group requires commitments of time and effort, and we are grateful for your sacrifice.

To prepare you to lead the study, Crown Financial Ministries offers a Life Group Leader Training. You will invest ten to fifteen hours of preparation before attending the session. Spouses are encouraged to attend at no additional cost. If spouses attend, they must complete all the training requirements, and their attendance must be reflected on your registration form.
